#### **INTRODUCTION**

#### I. About the Centre:

The National Centre for Good Governance (NCGG) has been established by the Government of India under the aegis of the Department of Personnel and Training by upgrading the erstwhile National Institution of Administrative Research (NIAR), Lal Bahadur Shastri National Academy of Administration (LBSNAA), Mussoorie, with an expanded mandate. NCGG is an autonomous institution registered as a Society under the Societies Registration Act 1860, with its Head Office at New Delhi and Registered Office at Mussoorie.

#### II. Mandate of NCGG:

The National Centre for Good Governance is envisaged to be the apex think- tank of the country that would guide Government and help in implementing good Governance reforms. It seeks to be a high-level institute for research and training to deal with the entire gamut of governance issues from the National to State to the local level and in sectors across the Government. It aims to be a national level multidisciplinary institute devoted to action-research and analytical studies for supporting good governance strategy, action plan and their implementation with its jurisdiction all over India.

The outcome of the Centre's work is in the form of research papers, studies on best practices on Governance reforms and policy analysis. Its goal is to provide the necessary direction, guidance and capacity-building inputs on Governance and management issues to the Central and State Government organizations, Central Training Institutes and State Administrative Training Institutes.

#### III. Objectives:

The objectives and functions of NCGG are:

- (i) To be the apex think tank of the country in guiding and implementing Citizen Centric good Governance reforms – administrative, social, financial and political.
- (ii) To function as a national repository on information on best practices, initiatives and methodologies that promote good Governance, e-Governance initiatives, change management and capacity building within the Government.
- (iii) To work towards resolution of key issues in governance, analysis of policy and programme implementation, develop action plans, support governance reforms and provide help in developing synergy across various sectors and Ministries/Departments of GoI, and State Governments.
- (iv) To initiate research into various aspects of regulatory and developmental administration, urban and regional planning, sustainable development, social sector programmes and public management/ public policy with special reference to agrarian issues.
- (v) To coordinate and organize training programmes sponsored by various government, non-government and foreign agencies. NCGG would provide direction, guidance and capacity building inputs on

governance and management issues to the Central /State Government organizations and Central Training Institutes and State ATIs in the form of research papers, best practices on governance reforms, policy analysis and options.

(vi) To hold National Consultations on topical issues, involving all the concerned stakeholders, with a view to evolve consensus with regard to the adoption and execution of policies in the public interest. To interact with other national and international organisations, in and outside government, engaged in research and training in subject areas of mutual interest;

#### IV. Governing Body:

NCGG is governed by a Governing Body, under the Chairmanship of the Cabinet Secretary. The affairs of the Society are being managed under the overall superintendence, direction and control of the Governing Body. The other members include secretaries of various departments of government of India, eminent academicians and members of Civil Society with expertise and interest in governance reforms. The composition of the members of the Governing Body is listed in *Annexure I*.

#### V. Management Committee:

NCGG has a Management Committee with Secretary, Department of Personnel & Training (DoPT) as the Chairperson. The other members are heads of reputed training institutes, research organizations and eminent administrators and academicians. The composition of the members of the Management Committee is listed in *Annexure II*.

#### ACTIVITIES OF NCGG DURING THE YEAR 2015-16

#### I. Governance

• One Day National Workshop on 'Citizen Centric Governance':

The National Centre for Good Governance (NCGG) and Department of Personnel and Training (DoPT), Govt. of India, in association with Institute of Development & Communication (IDC), Chandigarh and the Department of Industrial Policy and Promotion (DIPP), Government of India, New Delhi organised a National Workshop on Citizen Centric Governance on September 12<sup>th</sup>, 2015 at Vigyan Bhawan, New Delhi.

The objectives of the workshop were to

 (I) reflect on perspectives for Governance Reforms, E-Governance and Convergence of E-Governance with Citizen-Centric Governance – for both industrial promotion and need-based services

- (ii) share experiences of good governance initiatives in various states and to assess the efficacy of the various reform initiatives implemented by the various State Governments;
- (iii)communicate the work done by IDC, Chandigarh for simplification of procedures and proforma; and
- (iv) draft simplified forms of "Explosives Rules, 2008" to replace the existing AE-3, AE-4, AE-6, AE-7 and AE-8.

Secretaries/ Officers of the concerned Departments of the Union and State Governments, Chief Secretaries of State Governments and Directors/ Commissioners of the Departments related to industry and service delivery participated in the programme. Eminent personalities and subject experts served as resource persons and facilitated an enriching exchange of ideas.

Shri Arun Jaitley, Hon'ble Union Minister of Finance; Corporate Affairs; and Information and Broadcasting, GoI attended the Workshop as the Chief Guest during the Valedictory session. Dr. Jitendra Singh, Hon'ble Minister of State (Independent Charge), Department of Development of North Eastern Region; Prime Minister Office; Personnel-Public Grievances and Pensions; and atomic Energy and Space graced the occasion as the Guest of Honour.

## • One Day National Workshop on 'Citizen Centric Governance'

In this series, the second National Workshop on 'Citizen Centric Governance' was organized by the National Centre for Good Governance (NCGG) and Department of Personnel and Training (DoPT), Govt. of India, New Delhi in association with Ministry of Rural Development (MoRD), Govt. of India, New Delhi and Ministry of Labour & Employment (MoLE), Govt. of India, New Delhi on December 18, 2016 at Vigyan Bhawan Annexe, New Delhi for recommending simplification of forms and procedures for facilitating benefit under beneficiary oriented schemes of the MoRD, ESIC, EPFO and DGLW.

The outlines of the Workshop were:

- (i) Perspectives on Governance Reforms.
- (ii) Proforma Simplification for efficient and accountable service-delivery.
- (iii) Interaction with the participants/ stakeholders on the relevant issues of simplification.
- (iv) Group exercise on practical simplification of selected proformas of the concerned departments.

The Workshop was attended by the Eminent Resource Persons from concerned field/department, Secretaries/ Addl. Secretaries/ Joint Secretaries/ Commissioners of concerned Departments of the Union Government, Principal Secretaries and Directors of concerned Departments of the States and Representatives of various stakeholders.





# • A Talk on 'Good Governance – An Ethical Perspective

A Talk on 'Good Governance – An Ethical Perspective was organized by the National Centre for Good Governance on 29<sup>th</sup> February, 2016 at the India International Centre, New Delhi.

#### II. Water and Sanitation

# • National Key Resource Centre for Water and Sanitation

The Government of India, Ministry of Drinking Water and Sanitation has identified the National Centre for Good Governance, Mussoorie as one of the National Key Resource Centres. The Key Resource Centre (KRC) at NCGG is aimed at apprising the senior management personnel and key policy makers working in this sector with the latest developments in the field and to equip them with knowledge that would help them in developing a comprehensive understanding of the sector and enable them to make more effective interventions.

# • Capacity Building Training programmes on Water & Sanitation

The National Centre for Good Governance (NCGG) has been organizing a series of Capacity Building Training Programmes which have been entrusted by Ministry of Drinking Water and Sanitation (MoDWS), Government of India in both Water and Sanitation sector separately. Initially, the programmes were jointly conducted for both Water & Sanitation sector. From 2012 onwards the trainings are being conducted separately

for Water and Sanitation sector respectively. The target groups for these training interventions were the Administrators of development agencies, Engineers from PHEDs, Elected Representatives from PRIs and various voluntary organizations.

NCGG has successfully organised 4 Capacity Building Training Programmes during August 2015 to January, 2016 and trained 106 stakeholders on water issues at respective state capitals. The programmes organised during 2015-16 are listed in *Annexure IV*.

# • Swachh Bharat Mission (G) and Objectives

The Swachh Bharat Mission (G) was launched on 2nd October, 2014. It aims to achieve Swachh Bharat by 2019 as a tribute to Mahatma Gandhi on his 150<sup>th</sup> Birth Anniversary. The Mission's target is to improve the cleanliness levels in rural India through appropriate Solid and Liquid Waste Management (SLWM) activities by making the Gram Panchayats Open Defecation Free (ODF) clean and sanitized.

The main objectives of the Swachh Bharat Mission (Gramin) are:

- (i) to bring an improvement in the general quality of life in the rural areas
- (ii) to accelerate sanitation coverage in rural areas to ensure all Gram Panchayats attain Nirmal status up to 2019,
- (iii) to motivate the Panchayati Raj Institutions and communities promoting sustainable sanitation facilities through awareness creation and health education,
- (iv) to encourage adoption of ecologically and economically effective technologies for sustainable sanitation and
- (v) to develop community managed environmental sanitation systems focusing on overall cleanliness in the rural areas.





#### • Capacity Building Training Programmes on Swachh Bharat Mission (G)

The Ministry of Drinking Water and Sanitation (MoDWS), Government of India has assigned the National Centre for Good Governance to organize Training-cum-Orientation Workshops on Swachh Bharat Mission (SBM) for District Magistrates/ District Collectors/ Chief Executive Officers and Zilla Panchayat Presidents (DCs/DMs/CEOs/ZP Presidents) orientation training programme on Swachh Bharat Mission (SBM-G). The objective of the programme is to create awareness, gain knowledge and learn best practices and to ensure the better implementation and sustenance of national mission across the country. In this context, a series of Orientation Training Programme on Swachh Bharat Mission (G) are being organizing by NCGG in Two Phases. The 1<sup>st</sup> Phase was organized in 2015 where 113 DMs/DCs were trained. In

addition, the Centre, with its extra efforts, has organised 3 special training programmes for the District Magistrates, District Collectors and Chief Executive Officers for Madhya Pradesh where altogether 131 Officers have been oriented on Swachh Bharat Mission. The programmes organised during 2015-16 are listed in *Annexure V*.

NCGG has also conducted 5-Days Training of Trainers (ToT) Workshop for Key Resource Centres (KRCs) on CATS/CLTS with support from UNICEF, New Delhi and 3-Days Capacity Building Training Programme on Swachh Bharat Mission (G) CEOs/BDOs in varios places of the country.The programmes organised during 2015-16 are listed in *Annexure VI*.

#### . Trainings 2015-2016

#### Mid-Career Training Programme in Field Administration for Civil Servants of Bangladesh

The National Centre for Good Governance has been engaged to conduct Mid-Career Training Programme in Field Administration for Civil Servants of Bangladesh at NCGG, Mussoorie since April, 2013.

NCGG has successfully organized 11 programmes from April, 2015 to March 2016 and trained 975 Civil Servants of Bangladesh.

The objectives of the Training Programme are:

- To have an understanding of Indian Administrative and Governance Approaches.
- To gain an insight into the Indian Rural Development Approaches and Best Practices.
- To gain an insight into the Urban Development Plan and learn from the best practices adopted.
- To have an understanding of various good egovernance experiences on India in various



sectors.

- To learn from the Disaster Management Techniques and approaches through Case Studies.
- To have an exposure to Good Projects.

The programmes organized during 2015-16 are listed in *Annexure VII*.

## • Special Training Programme for Deputy Commissioners of Bangladesh.

In addition to the Mid Career Training Programme in Field Administration for Bangladesh's Civil Servants, the Ministry of External Affairs (MEA), Govt. of India, New Delhi assigned NCGG with the task of





organising 4 Special Training Programmes for Deputy Commissioners (DCs) of Bangladesh. NCGG has successfully conducted the programmes and trained DCs of all 64 districts. The programmes were very well r e c e i v e d b y the participants. The programmes organized during 2015-16 are listed in *Annexure VIII*.

#### Management Development Programmes

NCGG has successfully conducted 3 Five-Days Management Development Programmes for Senior Executive of Coal India Ltd. and Senior Officers of Lok Sabha Secretariat in the month of June 2016 at Mussoorie. In addition, the NCGG has also organized a Five-Day Training Programme on Public Policy and Governance for the Officers of Odisha Administrative Service. The programmes were very well received by the participants. The details of the programmes are listed in *Annexure IX*.

# IV. Centre for Climate Change & Environment (CCC&E)

The Centre for Climate Change & Environment (CCC&E) was established in the National



Centre for Good Governance (erstwhile National Institute of Administrative Research) in collaboration with the United Nations Development Program (UNDP) in 2011. Over the tenure of four years, the Centre has worked with LBSNAA and the State Administrative Training Institutes (ATIs) to develop Climate Change Training Modules for use as reference material for Civil Service Officers undertraining at these institutes. The Centre is committed to build capacities of Civil Service Officers on climate change issues by enhancing their knowledge-base and skill-set for effectively addressing the challenges posed by climate change in their sectoral domains. The Centre, in its capacity as a knowledge

institution, has also developed knowledge products on climate change.

Training material used by LBSNAA was reviewed and revised through engagement of KPMG India. Modules have been developed for Foundation Course, Inducting Training Programme, IAS Professional Phase I - Phase V courses. Accordingly, climate change courses were incorporated in the training programmes (Foundation Course, Phase I, Phase IV and Phase V) as per revised framework. During the year continuous follow up has been done with LBSNAA faculty and State ATIs for incorporating the modules in their training framework. Further, training material were developed for State ATIs after a Training Need Assessment exercise. KPMG India was engaged by UNDP, India to develop these modules which include common as well as region specific training modules on Climate Change for various geo-climatic zones of India i.e. Arid Zone, Central Zone, Coastal Zone, Himalayan Region, Indo-Gangetic Zone and North East Zone.

CCC&E has submitted a proposal to the Ministry of Environment Forests and Climate Change, Government of India to support its activities in order to continue contributing to the international and national commitments of India related to climate change.

## FACILITIES AVAILABLE AT NCGG, MUSSOORIE

The Building Complex includes Faculty rooms, officespacefor staff, library, computer laboratory, conference hall, guest rooms, dining hall, kitchen, and lounge.

The Library consists of a specialized collection on regional and urban planning, environmental studies, and reports on BSAS on Elementary Education conducted in various States by NCGG. The computerized catalogue and bibliographic services of the Gandhi Smriti Library of the Academy are also available for use of the Centre.

The Computer Laboratory has ten work stations, digitizing and scanning facilities, plotters, colour printers, word processing and statistical software.

The Conference Hall can accommodate up to 60 participants and is equipped with multi-media facilities.
