MEMORANDUM OF UNDERSTANDING

This **MEMORANDUM OF UNDERSTANDING (MoU)** signed in Itanagar on the 18th day of August, 2022 to strengthen the cooperation.

BETWEEN

The **National Centre for Good Governance (NCGG)**, which is an autonomous institution under the aegis of **Department of Administrative Reforms and Public Grievances (DAR&PG)**, Ministry of Personnel, Public Grievances and Pensions, GoI. It aims to promote good governance through Capacity Building on Public Policy and Governance both at National and International Level and carries out studies / action research on issues relating to governance.

AND

The **Department of Administrative Reforms**, the coordinating agency of the **Government of Arunachal Pradesh** in the matters related to public grievances, reforms in administration, framing of recruitment rules, career development, staff welfare, process re-engineering, re-organizing and restructuring of departments. The department is also concerned with the process of responsive people oriented modern administration. Allocation of business rules defines the work allotted for the department.

NOW IT IS HEREBY AGREED TO BY AND BETWEEN THE PARTIES AS FOLLOWS:

Article 1: SCOPE OF MoU

It has been agreed between the Parties as follows:



1. The objective of the MoU is to establish, maintain and enhance academic and intellectual interaction through specific initiatives detailed in this agreement with a view to promote excellence in Capacity Building Programmes and practices relating to Good Governance for the Training of 500 Senior Officials of the Government of Arunachal Pradesh Administrative Service Officers.
2. The Institutions mentioned hereinafter referred to as Parties, in furtherance of their mutual interest in research and training, and as contribution to increased bilateral cooperation between them, hereby agree, within the framework of the regulations applying in each of the institutions and subject to the availability of resources.

Article 2: TERMS AND CONDITIONS

1. The terms and conditions, under which a specific programme / activity shall be undertaken under the terms of this memorandum, and any necessary financial

arrangements to facilitate these will be mutually discussed and agreed upon in writing by all the parties prior to the intimation of the particular programme or activity.

2. Head or authorized representatives of the institutes (NCGG and Department of AR, Govt. of Arunachal Pradesh) will be the signing authorities for this agreement.
3. The institutions may agree every year by letters on the contents of the activities to be taken up on an annual basis.
4. This memorandum will enter into force from the date of its signing and will be valid for FIVE years. After that if none of the parties has given notice for its termination or for its review, its validity will be renewed automatically for another term of five years. It may be terminated by either party giving a one year notice to the other party in writing. The termination of the Memorandum shall not affect any activity already in progress.
