## Experience:

i. A minimum of 15 years teaching / research / industrial experience of which at least 4 years should be at the level of Associate Professor in any Institute of National Importance (INIs) or at an equivalent level in any such other Indian or foreign Institution(s) of comparable standards.

ii. Retired civil servants or Public Sector Unit (PSU) employees with experience in governance, policy-making & generating well-researched reports /publications.

OR

iii. The candidate should have 15 years of relevant experience and should have held positions of responsibility in a reputed industry/organization in the thematic areas of subjects enlisted above

## **Remuneration:**
